## SYSTEM OF RANKING DELIVERY UNITS OF ILOILO STATE COLLEGE OF FISHERIES

### I. Delivery Units

In line with Memorandum **Circular No. 2018-1** and to facilitate the ranking process of the Iloilo State College of Fisheries (ISCOF), the delivery units identified based on similarities of functions and responsibilities are the five (5) campuses namely; ISCOF Main Tiwi, ISCOF Main Poblacion, ISCOF Dingle, ISCOF Dumangas and ISCOF San Enrique.

### II. Ranking Distribution

The ISCOF Campuses shall be forced ranked according to the following distribution:

Ranking	Performance Category	No. of Campus/es
Top 10%	Best Campus	1
Next 25%	Better Campus	1
Next 65%	Good Campus	3

### III. Ranking of Campuses

ISCOF Campuses shall be ranked from 1 to 5 with 1 as the highest and 5 as the lowest for each Performance Indicator (PI) of the Major Final Outputs (MFOs). The ranking of campuses shall be based on the accomplishment rate of the targets. The average of the PIs for each MFO shall be multiplied by the weighted percentage of each MFO as shown below. The sum of the weighted MFOs of the campuses shall be ranked from 1 to 5. The lowest sum shall be rank 1 as the best campus and rank 2 as the better campus. The last 3 campuses are good campuses.
